

TERMS AND CONDITIONS of SALES (page1/3)**DEFINITIONS:**

Seller's sale of products is made solely and exclusively pursuant to and subject to the terms and conditions set forth herein, and no conflicting or additional terms or conditions whatsoever, whether stated in Buyer's purchase order or other communication or otherwise, shall apply unless such conflicting or additional terms or conditions are set forth in a separate writing executed by a duly authorized executive officer of Seller.

SATISFACTION GUARANTEE:

We closely oversee the crafting and shipping of every item we sell. If for any reason buyer is not completely satisfied we will accept a return for exchange or for refund (less S&H and restocking fee when applicable), provided the item is returned within seven (7) days from receipt of the goods if they are delivered unbroken. Should any of our products be delivered in a broken state, we should be notified in writing (by fax 213-947-1065) within 24 hours of product receipt and the product should be shipped back to us within 72 hours of its receipt with the return authorization number. A return product without authorization number will be sent back to the sender at the expense of the sender.

CONFIDENTIALITY OF INFORMATION GUARANTEE:

AIDL Ltd does not sell or distribute any information we acquire directly from our customers. This includes buyer's postal address, phone numbers e-mail address and any other personal data. We respect our customers' privacy!

SALES TAX:

All State of California residents are required by law to pay 8.25% tax.

TURN AROUND TIME:

Orders are usually shipped within 3 days depending upon size of order and quantities in stock. Occasionally, orders do take a few weeks if a product(s) is placed on back order or has to be custom-made. If prompt delivery is a concern, please call or e-mail us for product availability.

RETURNED CHECKS:

Any check being returned due to insufficient funds or any other reason will be submitted for collection immediately. Each returned check will result in an additional twenty-five dollars (\$25.00) service charge to the consumer.

DELIVERY TERMS:

All orders are shipped via either the United States Postal Service or EMS unless otherwise specified. The mailing provider may be changed at our discretion without notice.

SHIPPING AND HANDLING CHARGES:

Shipping and Handling charges depend on the merchandise, the destination and the provider. Shipping and Handling charges can be modified at any time according to the changes in the pricing of our mailing provider.

Special orders, non-stock items or returns not meeting (i) and (ii) may be returned after written authorization and shall be subject to the following deductions: (a) cost of putting items in salable condition; (b) transportation charges, if not prepaid; and (c) handling and restocking charges.
